The two envelopes containing 'A' & 'B' must be duly superscripted with above titles and put in another sealed envelope superscripted with the title 'Supply & installation of servers to High Commission of India'. Bids may be submitted in two different envelopes as per details given below: -

I. TECHNICAL BID –

The first sealed envelope (marked as Envelope "A" and superscripted as Technical Bid) should contain following documents regarding technical specifications of the company.

Both the sealed envelopes, should be placed in the main sealed envelope superscripted " Supply & installation of servers to High Commission of India" addressed to the Second Secretary (Project & Maintenance), High Commission of India, India House, Aldwych, London WC2B 4NA and must reach HCI before last date of submission of bids.
