## Scholarship Program (KUISP) for International Students Eligibility criteria and Information for Applicants

KIIT Deemed University India Scholarship Program (KUISP) is applicable only for international applicants (only applicable for courses under School of Humanities & School of Computer Applications & School of Mass Communication).

Applicants should fulfill the following criteria in order to be eligible to apply for the program:

- Applicants with good academic standing in their home institutions are encouraged to apply.
- Applicants should have a valid passport.
- Applicants applying should fulfill the course eligibility criteria.
- Documents that have to be provided in order to apply are as follows:
  - Copies of academic transcripts/mark sheets
  - Copy of School leaving Certificate
  - Copy of Degree Certificate (if applying for Master Programs)
  - Recommendation Letters.
  - Proof of English proficiency.
  - Copies of certificates of academic honors or awards received (if available).
- Applicants are eligible to apply for only courses under School of Humanities & School of Computer Applications (not applicable for SAARC countries)
- Applicants qualifying for the KUISP Scholarship program where Tuition fee is 100% free. **The students will only have to pay the fees towards their accommodation & Food:**
  - **Accommodation: (24X7 Internet and Intranet Facility)**
  - **AC hostel: USD 1450 per annum**
  - **Food: USD 480 per annum**
- Applicants should bear the traveling expenses to Bhubaneswar, Odisha, India and their personal expenses during the duration of study, Health Insurance.
- Applicant should abide by rules and regulation of KIIT University. \*T&C
- Deadlines
  - **Last date for recommendation of students: 30 JUNE 2023**
  - **Notification on the final list of selected students will be sent 5 July 2023.**
  - **Date of final admission is 15 July 2023**
  - **Classes: 1 August 2023**
