Government of India offers Scholarships to the children of Person of Indian Origin (PIOs)/ Non-Resident Indians (NRIs)/ OCI card holders and workers in Gulf countries, to pursue Under Graduate courses in Indian Universities/Institutes in different fields (except medical and related courses) both professional and non-professional.

Scholarship amount for payment of tuition fee, admission fee and post-admission services.

Financial assistance is upto 75% of the total Institutional Economic subject to a maximum of US \$ 4000 per annum

- Scheme applicable to 69 countries including 17 ECR (Emigration Check Required) countries.
- 150 Scholarships with 50 earmarked for Children of Indian Workers in ECR countries. One third of these 50 scholarships are reserved for children of Indian workers in ECR countries studying in India.
- Scholarships are offered for courses in :
 - Central Universities of India offering Under Graduate Courses.
 - Institutions accredited "A" Grade by NAAC (National Assessment and Accreditation Council)
